## COURSE OVERVIEW

In a group of 12-14 people and the trainer, students will have the opportunity to watch footage of Master Therapists working with a range of couples, using a variety of different approaches. The monthly seminars provide a demonstration of theory in action, allowing students to analyse the various interventions made by the therapist during the course of a complete interview (see video catalogue for details).

Students are supplied with a prescribed reading program which will focus on the particular approach being demonstrated, or the special issue being presented by the couple.

The Master Video Viewing program consists of 15 sessions over 18 months and students can commence in February or July. Participants can either sign up for the full 15 sessions, or commit to a minimum of 10 initial sessions and sign up for the additional five sessions at a later stage.

### Prerequisites

Successful completion of the Specialist Course in Couple Therapy.

### Course fees and materials

- 15 sessions \$1,534 (incl. GST)
- 10 sessions \$1,023 (incl. GST)
- Additional 5 sessions \$511.

An instalment option is available (for 10 and 15 session fees only), which incurs a \$50 administration fee.

*Note: these fees are subject to change.*

In addition to course fees, students will be charged for the prescribed reading collection catalogued into monthly packages, which summarises each theory topic. The cost of these materials are:

- 15 sessions \$124 (incl. GST)
- 10 sessions \$82.50 (incl. GST)
- Additional 5 sessions \$41 (incl. GST)
